

Treasury: Report by Jeri Jo Blackmon - we have revenue from 4 advertisers, down from 12 reflecting a 13% decrease in funds. We used to have an advertising person that would solicit advertisers, but we don't have one anymore. We need volunteers to help with soliciting ads for our newsletter. Cost to advertise in MH newsletter: small business card size: \$25, quarter page: \$50, half page: \$100, full page: \$200. Advertising is not expensive so if you know someone or if you are at a business, ask them if they would like to advertise in our newsletter.

In our neighborhood, 48 of 500 homes have donated to the annual dues drive – down by 50% from last year. We need more donations from neighbors. Donations contribute to events such as July 4 parade, Christmas party, welcome baskets, etc. Net income is down 84% compared to last year. Meeting attendee suggestion: set up a booth or table at the July 4 parade asking for donations.
