## It's time for the dotted line! (or not) Gas Lease Signup event November 1

Fort Worth Energy, in conjunction with XTO Energy, has approved a gas lease for Mistletoe Heights (MH) mineral owners which includes the following:


- 1) Drill site must be more than 600 feet from any home within MH
- 2) No truck traffic is allowed on any roads or streets within MH
- 3) Noise levels must be within current limits set by the Fort Worth Gas Ordinance
- 4) Waiver of all surface activity within MH including exploration, gas transmission pipelines, etc.
- 5) Mineral owner makes no warranty of title
- 6) Drill site is not along Mistletoe Blvd (will be north of Rosedale)
- 7) Compressor will be over 1000 feet from any home in MH

The MH gas lease committee has been working on an environmentally friendly lease for almost a year and believes this lease with FWEC/XTO represents the best possible terms for Mistletoe Heights residents. **As stated before, the decision to sign this lease or not sign is an individual decision.**

Fort Worth Energy will be sending a package to each mineral owner in Mistletoe Heights containing a cover letter, the lease and a Schedule 1 which will state the amount of your net mineral acres. To compute the bonus you will need to multiply your net mineral acres by \$15,000 per acre. This package should arrive by October 29. If you have not received your package by that time please contact Fort Worth Energy at (817)921-1889.

Berkley and Ryan Place residents have also been offered a similar lease. Fort Worth Energy has reserved Colonial Country Club at 3735 Country Club Circle, for the efficient completion of the lease documents.

Berkley and Ryan Place were scheduled for Oct.



23 and Oct. 30 respectively. **The date set for Mistletoe Heights residents at Colonial Country Club is November 1, noon to 8 PM.**

A representative of the Mistletoe Heights gas lease committee will be present during this time to answer questions as needed.

Since the bonus and future royalty payments will be based on the surface acreage for each mineral owner it may be helpful for you as homeowners to calculate your acreage using the conversion factor of

1 acre = 43,560 square feet

*Editor's note: If you know the depth of your lot, multiply it by the frontage, in feet, to get your square feet. Divide that number by the conversion factor = your fraction of an acre. They got mine exactly right. Lots in Block 11 (2200 W Magnolia & 2200 Harrison), are 129 feet deep.*

During the last phase of our deliberation, president Hao Tran created MHA Urban Gas Drilling Blog at <http://mhagasdrilling.blogspot.com/>

She did this to give us a place to have dialog on the issue and not clog up our MHA email system.

# Continuing our conversation with Heather White

*Last month we began an interview with Heather White, our former liaison with the Historic and Cultural Landmarks Commission. She had recently stepped down from chairing our committee. Here is the second half of our conversation.*

**Mistletoe Heights Association:** How many people are on our committee? When does it meet?

**Heather White:** About a dozen people with approximately monthly meetings. Some months we didn't have cases, so we didn't need to meet. We might discuss a simple case by e-mail. What gets unreasonable is when not very many people are making an effort. So when more people are involved it's definitely a good thing—many hands make light work. We need that in our neighborhood.

Something that was very important to me, and I hope will continue to be important going into the future, is fairness. I remember when I was going to HCLC hearings for my own COA [Certificate of Appropriateness] and designation, Betty Hicks, who was instrumental in the Handley district, was there too. She had finally found salvaged transom windows for her commercial property, and didn't realize that she needed a COA to remove the boarding and install them. I still remember her talking about how she didn't want anyone to think that she thought she was above the law because she had helped form the district, and I thought that was really great.

My goal was always to be blind to the name on the application, and to examine each one in the same way. Sometimes people seemed insulted by this. To me, that approach shows respect for everyone, as well as the Guidelines, the whole process, and the historic buildings we're meant to be protecting.

When I appeared before the HCLC myself, I was questioned closely about my plans, and I thought that was a good thing. So I hope people will be open to that dialogue.

I also would equally hate to see the Guidelines used to oppose an applicant that the powers that be in the neighborhood don't approve of. Each case needs to be evaluated on its own merits, and nothing else.

**MHA:** We saw the house demolished in July at 2126 Harrison. What do you think will happen down on the 2100 blocks? Any comments on this one?

**HW:** I heard a lot of input from people in our neighborhood who couldn't imagine anyone wanting to live in a 880-sq-ft house. I think people forget how very far up most of us in this neighborhood are on the economic ladder in this country. I remember coming across a tool where you could see the percentile of your home's value in comparison to all other homes in the area. I was shocked how far up mine was—and it certainly isn't one of the more expensive homes in our neighborhood.

We forget how privileged we are, and how appealing that small house might be, either to someone looking for affordable housing they can own for the first time, or someone concerned about the

environment and wanting to minimize her footprint. There's an article in [last] month's *Cottage Living* about a couple who've been living in a 720-sq ft house in Seattle for some years now, and are just about to build a 200-sq ft addition. They both work for an acting company that performs for children, and their little cottage and garden are the fulfillment of their dream. They've put all their artistic expertise in building sets to work, and they've brought their little 1909 house back to life.

We did meet with Mike McDermott during the process—he was (and is) my counterpart for the Fairmount neighborhood's preservation committee. He gave us some good advice, and he too was of the opinion that 880 sq ft was quite useable—and gave us examples of that right here in Fort Worth. 880 square feet is just 500 square feet less than my house, and I'm certain I only use that much of my space or less every day. Mike's suggestion was to move these contributing structures [houses] to create a space for new construction and also preserve those buildings.

**MHA:** Tell us about the discussion of demolition.

**HW:** When we were debating whether the house at the corner of Harrison & Jerome should be torn down, we wanted to get advice from the most experienced people we could think of. I also asked Joel, whose term on the HCLC had just expired, to attend the same meeting Mike came to. He agreed to meet with us, but ultimately didn't—I don't know the reasons for that.

We were concerned about how we were going to maintain the integrity of the Guidelines, which are pretty specific about what you can and can't do, regarding demolition.

We got input from a neighbor who lives on a 2200 block and had been instrumental in the overlay, as well as two other accompanying neighbors from the same area who were in agreement. The input was that "no one" on the 2200 blocks wanted that house preserved. That the house would be a contributing property on another block, but not that block. (I never understood that—I couldn't see how which block it was on made any difference.) All of the neighbors expressing opinions in favor of preservation at the time happened to live on 2300 blocks or the Drive, and we were told that our opinions didn't count, because we "didn't have to live with it." That's why I was surprised to read your column, and I'd like everyone to realize that your opinion, and everybody's opinion, does count. Our historic district doesn't belong just to a few elite people—but to all of us.

But, it doesn't do any good if you don't express it! If you make the effort to get down there to the HCLC or express it to the neighborhood committee, that counts.

I also love to hear you reminisce about your years in the neighborhood. You're a very near neighbor to the 2100 blocks, and when I talk to you, there's no "us" and "them," there's just all your neighbors, and all the kids your son grew up and was friends with, and you're clearly fond of all of them—their house number makes no difference to you. And honestly, why would it?

**MHA:** OK, you've drawn me into being the subject now, instead of you! But that closeness between my block [2200 W Magnolia] and 2100 Harrison endures. My son's 25 now. Those were his buddies in the '80s and '90s. Some of the families still live here; some don't—the grandmas in the shotgun shacks on 2100 W Magnolia, they are all gone.

Kids on our block today have school friends and playmates from everywhere, including the 2100's. Not much changed besides loss. Life is pretty fluid on my block; we communicate, see each other outside in our front yards most every day. Back to my questions for you, now.

The day of the demolition, I was a witness. Were you involved?

**HW:** I got a call from someone nearby the day it happened. She said, "I guess we couldn't stop it." I have really just had to distance

myself, because it really just makes me ill to think about all the hard work we put into making the Guidelines mean something.

**MHA:** Oh! Probably my neighbor called you. She walked down as I took the pictures that day and said she spoke to a neighborhood official who told her how the HCLC meeting went when they approved the demolition.

**HW:** I'm not sure if she's the same person who called me, but I wanted her to know that there was a COA for the demolition, it wasn't being done without permission. But I do want to make it clear, I truly believe that we could have stopped it.

We were definitely absolutely in a position to stop it and what happened was we got very strong input from a neighbor on the 2200 blocks, and then from two additional neighbors, and we didn't hear any opposing positions from anyone on that side of Forest Park. Those folks who did talk to us were very determined to see that house come down. That really shows you the difference one person can make.

So it's very important, if you have an opinion, please express it to the HCLC, and to your neighborhood committee.

The HCLC will not enforce our Guidelines if the folks from the neighborhood are telling them not to, that's the bottom line.

**MHA:** What advice would you give us looking to the future?

**HW:** I hope this is a wakeup call to say if there's something you care about in the neighborhood, say so. We do have the power to stop demolition, as well as to make all kinds of other things happen, if we stand up and say something. We have the power.

**MHA:** I feel like this was my wake-up call also. I hadn't paid attention and didn't know where to voice my opinion, other than that one meeting of MHA at the zoo last year. If we care for the future, we should heed your advice and speak up. Thanks, Heather.

**HW:** Thank you, Claudia. The newsletter looks great—thanks for all you're doing for the neighborhood.
