

Mistletoe Blvd to Close for Six Months

I received a call from Chuck McLure with the City of Fort Worth informing me that a portion of Mistletoe Blvd will be closed from Wednesday, September 19, until the middle of March, 2019. The street will be closed between the railroad tracks and Leslie St to the east. The closure is due to construction updates to storm drains and other infrastructure ahead of the planned Mistletoe Station apartment complex to be built on the north side of Mistletoe Blvd.

Historic overlay helps preserve character of the neighborhood



Mistletoe Heights is a historic neighborhood, dating from the 1910s. Wishing to preserve its architectural heritage and identity, most of the neighborhood is included in a historic overlay.

Any alterations or additions to the structures should be submitted to the neighborhood Historic Preservation Committee and must be approved by the city of Fort Worth's Historic & Cultural Landmarks Commission (HCLC).

How did our Schools Score?

In August, the Texas Education Agency released its first official "A-F grades" for Texas's 1,000+ school districts. The program is intended as an accountability system to determine the quality of our public schools. The grades are a composite of three metrics: (1) Student Achievement, which measures whether students met grade-level expectations on the STARR exam; (2) School Progress, which largely focuses on students progress on the STARR exam from the previous year; and (3) Closing the Gaps, measures the percentage of different groups of students that are performing above state goals.

Overall Fort Worth ISD earned a solid "C" grade. Arlington also received a C, with Dallas beating us with a low B. Technically, individual schools did not receive individual grades for this school year. Instead schools received a numeric score that we can all easily translate to letter grades. 75% of FWISD's schools unofficially received an A-C grade. Next year, schools will officially receive grades.

Within our neighborhood, our own schools received the following overall scores:

Lilly B. Clayton	McLean	Paschal	Young Women's Leadership Academy
87	82	84	92

Without wading too deep into the political debate, the new grading system has generated plenty of controversy. Parents' groups, teachers, and school districts (including FWISD) have protested whether the system properly evaluate school's quality since it primarily relies on standardized test results. The debate aside, the scores are out and will be followed closely over the next few years.

Steps to Avoid Package Thieves and Break-ins

Fortunately, most crime in our neighborhood can be attributed to packages walking off or loose change going missing from our cars. Here are a few pro-active steps you can take to deter thieves:

1 Don't leave Valuables in your Car:

It cannot be said enough: don't leave valuables in your car and lock your doors. As indicated by Officer Carpenter at our last neighborhood meeting, nearly all cases related to car burglaries involved unlocked cars.

2 Indicate you have a Camera:

Many of us have video doorbells or home security cameras that catch people walking up to our porches or cars. A recording helps after the fact but doesn't always deter a thief, especially if he doesn't know he is being recorded. Displaying a yard sign or window sticker indicating active video surveillance alerts thieves to second-guess their approach onto the doorstep.

2a Register your Camera:

If you have a video camera on your porch you can register it with the Fort Worth Police Department through its Community Camera Program. This lets the police know if there are cameras in the area that may have relevant footage. They will request that you let them review the footage (you aren't giving them unfettered access to the camera). Visit the following site to register:

3 Use an Amazon Locker:

For some packages you can have them delivered to your office or a local locker instead of your house. Without being a paid sponsor for Amazon, it does conveniently offer lockers throughout the city. It will deliver the package straight to a locker and lets you retrieve it with an individualized access code. For us, the closest locker is located at the 7-Eleven at Forest Park and Park Hill. **Bonus:** the lockers help if you want to deliver a gift that you don't want a significant other see delivered to the house!



4 Sign up for Delivery Notifications:

Make sure you get text alerts notifying you when a package gets delivered. This way, at least you can try to beat the thief to the porch or ask a neighbor to grab it first.

5 Report, Report, Report:

If you are the victim of a car break-in or a stolen package, be sure you file a report with the City of Fort Worth Police Department. Its critical that you file a report because they are used to decide how to allocate police resources.

August 21 Neighborhood Meeting Minutes

CALL TO ORDER:

Corey began the meeting and distributed an agenda.

APPROVAL OF MINUTES:

Motion to approve minutes from May meeting. Approved.

UPCOMING EVENTS:

Movie night: Saturday October 5, 7:00 pm at Newby Park.
Movie TBD.
Pumpkin carving contest: October 30, at sunset.
Bow Tying Party: Sunday November 11, 2:00 pm at Gary Willis' home at 2237 Irwin.
Next Neighborhood Meeting: November 20, 7:00 pm.
Location TBD.

GUEST SPEAKER:

Officer Cory Carpenter was introduced and discussed various topics including: National Night Out: Tuesday October 2. He encouraged all residents to participate by turning their outside lights on and spending the evening outdoors. Car Theft: there's been a spike in car burglaries with 19 BMVs and 6 near our neighborhood. In all cases, there was something of value visible in the car. UPS Drop Box Thief: a UPS drop box thief, who knows the door codes, has stolen from boxes located at: FPB & Rosedale, Windsor & 8th, and the University parking garage. Mr. Jakes/ Phillips gas station: skimmers were found in card readers on outside pumps. It's estimated the skimmers were there 5 days. If you filled up with gas at this location, check your bank account. Suspicious person: Today he responded to a suspicious-person call the received 15 minutes after the person was witnessed which is ample time to escape. Report suspicious activity ASAP. Call Officer Carpenter for non-emergencies but anything suspicious or urgent, call 911. Stolen Packages: file a police report on all stolen packages so it becomes a record and they can track time and location of incidents. Speeding on FPB: he stopped someone going 53 in a 35-mph zone on FPB. Officer Carpenter requested a list of streets where speeding is a concern and he will increase patrol of those areas. Mark Philpot requested all streets be emailed to him (mark@leaguere.com) and he will send an email to Officer Carpenter. This concluded Officer Carpenter's visit. He was thanked for his time and left the meeting.

OFFICERS REPORTS:

Presidents Report: Sidewalk Update: per Clint Hoover, w/ City, sidewalk installation on Mistletoe Drive will begin September 4, completion date December 3; about 90 days. Streetlights: Washington style lights, predominant in MH, are not present on Harrison & Morphy. Corey spoke with Brendan McInnes and was told the cost to replace streetlights with the older-looking style would be \$7,000 to \$11,000 per light and the city will not pay for it. This was confirmed with Ann Zadeh's office. Security: Darren George, president of Berkeley Heights, is looking into adding cameras at main entrances to Berkeley. Cameras are motion activated, record street activity and license plate numbers. Darren approached Corey asking if MH would be interested in adding these cameras to our streets thus sharing the cost. Cost is about \$1500 per camera. This conversation segued into possibly hiring a patrol officer for times when petty crimes increase, like Christmas. Jeff investigated the cost of hiring a patrol officer: \$50 per hour, min 3-hour patrol in a marked police car. For 3 nights/ week it's \$500. Email Jeff with questions: (jeffdparks@gmail.com). He is also looking into crime stats, i.e., time of day, etc, of petty crimes and is finding it difficult to get accurate information reflecting our neighborhood since not all stolen packages and BMVs are reported. When you file a report, police patrols increase. Filing a report can easily be done online.

Vice President Report: MH Street sign Toppers: Mark spoke with the City and they will put Mistletoe Heights "Toppers" on street signs where they are absent.

Treasury Report: the treasury report was distributed with key points reviewed. Average cost to water the berm is \$175/ month, a drip system installed by the City. Newby Park water bill is \$85/mo. J. Bryant indicated he would like to investigate the water situation at Newby and the Berm as the bill seems high. This was met with assent. Next, a dues donation sheet was distributed which listed names of MH residents that have paid dues. If you're not on the list, then you haven't paid dues. Of 500 people living in MH, 20% pay dues. Discussion followed about how to get more people to participate in dues donations. Idea: provide an incentive, i.e., window stickers, coffee mugs, and T-shirts with MH logo.

Newsletter Report: The cost to print the newsletter is \$500 each distribution. Some people only read the digital version. What followed was a discussion on the pros/cons of going digital thus reducing the number of paper copies. The conclusion was to not pursue the idea for now as it would be too complicated to keep track of those who want a paper copy and those who do not. Presently, advertising income covers the cost to print the newsletter.

OLD BUSINESS

Triangle electricity and irrigation discussion: The concept of providing electricity and irrigation to the Triangle began August 2015 and was presented at neighborhood meetings on multiple occasions. The triangle is a common space and the goal is to make it look representative

of our neighborhood. Irrigation will be essential to keep grass healthy. If we want irrigation, we'll need electricity first. Our goal right now is to get electricity since we need it for movie night, bounce houses, band, and other events throughout the year. At the May neighborhood meeting, a motion approved spending \$10,000 on adding electricity and water to the triangle. Robert DeVargas met with Oncor and a contractor. Oncor will install 200-amp service and pull the line for free. To get electricity to the triangle, there is a transformer located on Buck. Two options for running electricity from this pole: under or over. Underground involves boring under a driveway and street. At the street, it would need to be placed 6' down. Cost to bore: \$7,000. Overhead: sink a pole on the Triangle easement and run the power line overhead (price unknown). Concern for the latter option are neighbors along this street may object to a power line overhead. Solar power was discussed but it would help with irrigation, not electricity. Also, Solar technology advances may present a problem over time. A favored response argued for spending money now so that in 20 or 30 years there's a quality system in place. Fund raising opportunities will be investigated further, i.e., sell bricks to cover corners on the triangle where grass does not grow. Suggestion regarding park benches: place two at right angles to each corner to create a conversational area.

Objection to Triangle irrigation/electricity: opposition was against spending discretionary money and the question of what happens when we need money and don't have it?

Motion made by S. Ewing: Pursue underground placement of electricity dependent on final cost if it does not exceed \$10,000. Seconded by C. Jung. Approved.

NEW BUSINESS

A home on Irwin is turning 100 this year and the home owner wants to have a street party. All of MH neighborhood is welcome to attend. Tentative date: October 27. A discussion followed about what is involved in blocking off the street. It requires approval from the city and signatures from most residents on the street. Look for the party to be posted in the newsletter.

September 2018 Yard of the Month

Hi, neighbors,

David and I were on vacation at the time we'd normally have chosen last month's Yard of the Month and the week before that it was well over 100 degrees! You remember 109, right? So we decided a YoM vacation wasn't such a bad idea... But we're back and very appreciative of all your efforts to keep those green things growing through what my mom used to call the dog days of August (actually I just looked that phrase up on Wikipedia and discovered it has nothing to do with heat, but I'll leave the astronomy lesson for another time).

At any rate, our yard radio was tuned to "cool" this month, and we found it under the huge, multi-trunked oak tree centered in the uniquely structured bed in front of the Craigs' home at 2111 Weatherbee. I've admired this large, circular-walled bed for as long as I've lived in Mistletoe Heights. It's made of the same creamy yellow stucco as the house and topped with red bricks that match the red tiles of the roof and front walk and patio. But the bed hasn't always been planted as prettily as it has been since Lorin and Casey Craig and their daughters Alyssa (15) and Addison (12) moved in in 2015. Lorin is a Fort Worth native and Casey is also originally from nearby Burleson. They'd moved to MH from Granbury, where Casey has a car dealership.

Both Lorin and Casey take active part in planning their garden. Casey, Lorin says, always wants color, and that's led them to depend on summer annuals this year, though Lorin keeps



thinking about how to incorporate some reliably blooming perennials in their shady garden. But the annuals encircling the oak tree are working very well now in the face of summer heat. These include purple and lime green coleus interspersed with different varieties of red, white, and green caladiums. Low-growing, deep purple ajuga arcs across the front of the bed, while mounds of blackfoot daisies (white flowered, despite their name!) are dotted all around the outside edge of the circle. Lorin and Casey are awaiting the return of the bright white and deep pink sunpatiens whose leaves and flowers were devoured by grasshoppers earlier in the season! But you can already see those leaves returning, so look for more bright color here in the coming month.

Though the circular bed dominates the front of the yard between the driveway and red-tiled front walk, there's still more to see! The circular structure is complemented to the right of the walk by a straight retaining wall of the same stucco and red-brick. Both are neatly skirted by crisply trimmed Asian jasmine, which continues around the corner and along the bank at the side of lot. In front of the straight wall are two very large pots brimming with cascades of pink bougainvillea along with a large decorative rock.



Also eye-catching are the planters that line the low, columned front porch wall. Here thrive masses of dragon-wing begonias above curtains of graceful trailing creeping jenny (aka moneywort). Pots of coleus top the steps on either side and two stands of ferns mark the front doorway. A study frame at the far right of the porch supports a large wisteria, which shades the porch from the afternoon sun as well as offering fragrant purple flowers in the spring (surprisingly, there are even a few there right now!). In front of the porch is a low, oval bed—red-brick trimmed like the larger one, whose plants suffered a casualty recently when one of the limbs of the oak tree fell in that direction, also taking out part of the tile roof. No one ever said that maintaining a garden was easy! But, then, what a great chance to look for new plants!

Thanks to the Craigs for their lovely and carefully maintained front garden. And happy gardening to all as the weather finally cools!
